



TERMS & CONDITIONS FOR THE CONTRACT / CO-TERMINUS APPOINTMENT FOR THE ABOVE SAID POST ARE AS UNDER:-

1. The candidate must be bonafied Himachali.
2. Age of a candidate shall be reckoned as on 01.01.2024.
3. The appointment is purely on Co-terminus basis (Fixed salary) for a period of 12 months /10 months /6 months according to the post. If the contract is not extended further, the same will lapse automatically without assigning any reason. The appointment can also be terminated at any time, on either side, by giving one month notice.
4. Age Relaxation will be given to reserved category candidates / ex-service man under the rules applicable. The age relaxation is also for Candidates working in Health Department in H.P. State.
